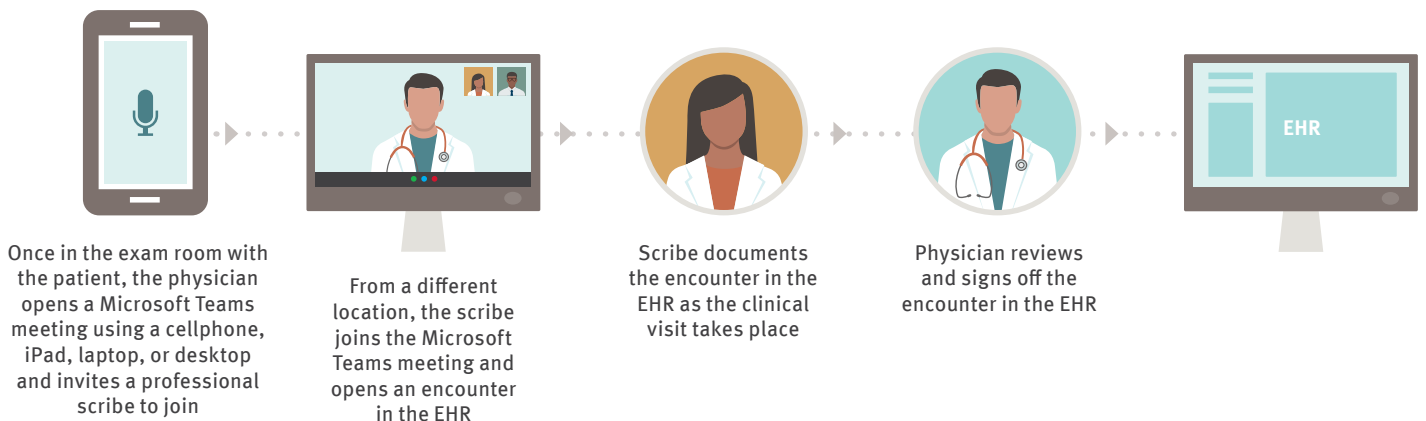

Medical scribing made easier

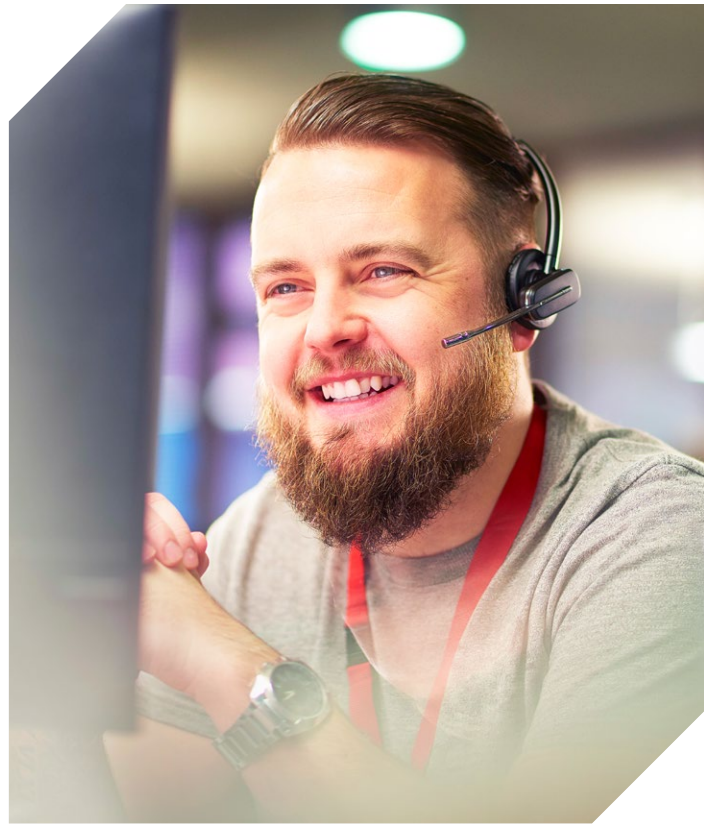
